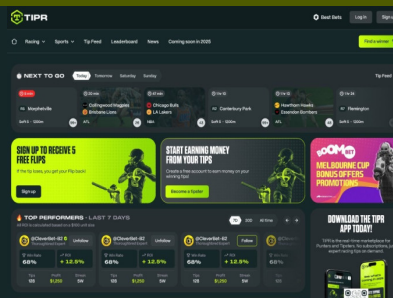

Sports Entertainment Network (\$95m market cap) own 7.5%. Additional capital is needed now for the v2.0/web-version launch this August.

TIPR is a real-time digital marketplace where punters can buy and sell tips on racing and sports with zero risk. Punters pay just \$1 per "Flip" and automatically receive their money back if the tip loses. Tipsters only earn when their tips win.

The platform uses a dynamic Elo-based rating system to promote the best-performing tipsters in real time. With Sports Entertainment Network (SEN) holding 7.5% equity and v2.0 launching soon (sports, multis & web platform), TIPR is positioned to capture a share of the large and growing global tipping/advisory market.

It operates on a simple, transparent commission model — the platform and tipsters only make money when punters win.

We are currently finalising v2.0 (full sports tipping, multis, exotics + web platform). At just 10,000 active users, this will generate \$3.64 million in annualised revenue.

Ownership shares start at \$25,000 AUD.

Business Resources

TIPR operates with a lean, highly efficient structure. The company is led by Founder & CEO Duncan Shaw, with all development, design, and data science currently outsourced to specialist partners (Pink Panda for development, GMTI Consulting for algorithm & data work).

We utilise modern cloud infrastructure (AWS hosting, React Native app, Laravel backend, Firebase) and maintain a virtual office in Sydney. Strategic support includes Sports Entertainment Network (SEN) as a 7.5% equity partner. No significant physical equipment or full-time staff are required at this growth stage.
